- Flex may play both offense and defense for the DP at the same time. Line up goes from 10 to 9 (or $12 / 11$ to $11 / 10$ with AP) and may legally end that way if the DP doesn't re-enter.
- Flex may be substituted for at any time by the DP or a substitute. If by the DP line up goes from 10 to 9 (or 12/11 to $11 / 10$ with AP) \& may legally end that way if the Flex doesn't re-enter.
- Flex and DP may play defense at the same time.
- Flex may not play offense only (unless using a AP).
- Flex may not play offense at the same time as the DP.
- The same player may not be listed as both the DP and Flex on the line up card.
